### **General Information**

The United States Bankruptcy Court for the Western District of Tennessee is accepting resumes for the position of full-time Term Law Clerk for its Jackson office. The judge has the option to extend the appointment at his discretion, but not to exceed four years from the date of appointment

Law Clerks appointed to term appointments are subject to social security deductions and are eligible for health, dental, vision and life insurance coverage and participation in the judiciary supplemental benefit programs. The incumbent is not eligible to participate in the retirement system or Thrift Savings Plan. The incumbent is eligible to accrue vacation and sick leave.

# **Qualifications**

To qualify for the position, one must be a law school graduate at the time of appointment with academic standing within the upper third of the class and must possess excellent research, writing, and communication skills. Membership (along with active participation) in law review, moot court, and/or a publication in a law review journal is preferred. Appointment to JSP 12 requires one year of law clerk or legal work experience and bar membership.
