

**ORDER LIMITING THE POSSESSION OF FIREARMS OR WEAPONS IN ALL BANKRUPTCY
COURT SPACE LEASED THROUGH THE GENERAL SERVICES ADMINISTRATION**

Pursuant to the annexed Memorandum dated October 11, 1988, from the Chairman of the United States Judicial Conference Committee on Court Security and the inherent authority of the court, and unless otherwise expressly authorized in writing by a United States bankruptcy judge for this Judicial District, the possession of firearms or weapons including Tasers in any space that the United States bankruptcy court for this Judicial District leases through the General Services Administration ("GSA") including courtrooms and clerk's office occupied space are expressly limited to employees of the United States Marshals Service including Court Security Officers assigned to the United States bankruptcy court. Accordingly, all persons, including bankruptcy court employees and law enforcement officers other than employees of the United States Marshals Service and/or Court Security Officers assigned to the United States bankruptcy court, shall be required to leave their firearms or weapons including Tasers at the United States Marshal's Office or with the Court Security Officers located at the United States bankruptcy court for safekeeping before they can be admitted to any space leased by the United States bankruptcy court through the GSA including all bankruptcy court courtrooms and clerk's office occupied space.






