General Order No. 08-0005

**ORDER RESCINDING SEPTEMBER 6, 2005, EFFECTIVE ON OCTOBER 17, 2005,  
"GENERAL ORDER ADOPTING ATTACHED INTERIM BANKRUPTCY RULES"**

It appears to the Court that on September 6, 2005, effective on October 17, 2005, the attached "General Order Adopting Attached Interim Bankruptcy Rules" ("Prior Order") was entered. It now appears to the court that the following new rules and amendments to the Federal Rules of Bankruptcy Procedure will take effect on December 1, 2008, unless Congress acts to the contrary:

Bankruptcy Rules 1005, 1006, 1007, 1009, 1010, 1011, 1015, 1017, 1019, 1020, 2002, 2003, 2007.1, 2015, 3002, 3003, 3016, 3017.1, 3019, 4002, 4003, 4004, 4006, 4007, 4008, 5001, 5003, 6004, 7012, 7022, 7023.1, 8001, 8003, 9006, 9009, 9024, and new Bankruptcy Rules 1021, 2007.2, 2015.1, 2015.2, 2015.3, 5008, and 6011.

It further appearing to the Court, except for Interim Rule 5012 (*Communication and Cooperation with Foreign Courts and Foreign Representatives*), because the above-referenced new and amended rules, effective on December 1, 2008, will supersede the Interim Rules addressed in this Court's Prior Order, unless Congress acts to the contrary, that the Prior Order should be rescinded, effective on December 1, 2008, unless Congress acts to the contrary.

Based on the foregoing, **IT IS ORDERED**, except for Interim Rule 5012, that the September 6, 2005 "General Order Adopting Attached Interim Bankruptcy Rules," effective on October 17, 2005, is hereby rescinded and vacated, effective on December 1, 2008, unless Congress acts to the contrary.




