



and Prior 12 Month Intervals**







Jul 1, 2018 thru Jun 30, 2019**










and Prior 12 Month Intervals**





Jul 01, 2019 thru Jun 30, 2020**




**Bankruptcy Case Closings
Jul 01, 2018 thru Jun 30, 2019**







