She was an ABA Presidential appointee to the Standing Committee on Pro Bono and Public Service and the Standing Committee on Legal Assistance to Military Personnel (LAMP) for several years. She has supported the legal profession at the state level as New Jersey Supreme Court appointee to the Board of Bar Examiners as a bar exam grader for 12 years and as a member of the Fee Arbitration Panel, Civil Practice Committee, and Model Jury Charge Committee. She has a passion for public service and pro bono and looks forward to collaborating with the Memphis Bar on outreach programs.

Dawn earned a BS from American University, a JD from Seton Hall University, and a LL.M from Temple University.

## PACER – What is it and who can use it?

PACER (which stands for Public Access to Court Electronic Records) is an online database which provides access to over a billion court documents filed in the federal court system. PACER is not only available to attorneys and court filers, but also to the general public. It can be used by parties represented by counsel and those who are not.

There is no charge to register for a PACER account; however, parties are charged a per page fee for accessing documents. Documents can be saved and/or printed.

When registering for a PACER account, you must select the appropriate "User Type" from the dropdown menu at the bottom of the registration page. For instance, if you are a party or member of the public, do not register for a Commercial Account, Government Account, or Individual Attorney Account. Rather, you need to select "Individual," "Student," or "Plaintiff, Defendant, or Debtor in a Case."

#### Adjustments to Dollar Amounts effective April 1st

Effective April 1, 2022, the dollar amounts stated in various provisions of Title 11 (aka the "Bankruptcy Code") and one provision of Title 28 of the United States Code were adjusted for cases filed on or after that date. A chart showing the affected sections, with current and adjusted dollar amounts, can be found <u>here</u>. The adjustments reflect the change in the Consumer Price Index for All Urban Consumers published by the U.S. Department of Labor.

Revised forms that reflect these changes will be effective on April 1, 2022 and will apply to cases filed on or after that date. Pending changes in the Bankruptcy Forms can be found on <u>https://uscourts.gov</u>. Updated local forms will be posted to the court's website on March 31, 2022.
