#### Welcome Clerk of Court, Travis Green

Travis Green has been named the new Clerk of Court for the Western District of Tennessee Bankruptcy Court. Mr. Green's first day was January 27<sup>th</sup>. Travis, a lifelong Memphian, served a stint in the US Marine Corp as an infantryman and previously worked in General Sessions as the Chief Administrative Officer.

#### **AJTA - Automatic Judge Trustee Assignment**

As courts nationwide are finding ways to do more with less, identifying procedures that can be made more efficient, and/or improving overall accuracy, filers and parties in cases filed in the Western Division (Memphis) have begun seeing several changes in how CM/ECF assigns judges and trustees to Ch. 13 cases and sets first meetings and confirmation hearings.

- Effective Tuesday January 7, 2025, CM/ECF began automatically and randomly assigning judges and trustees to all Chapter 13 cases filed in Memphis through use of the Automatic Judge/Trustee Assignment (AJTA) component of CM/ECF.
- Both Chapter 13 trustees in Memphis will now have cases randomly assigned to all three judges in Memphis.
- The first 341 settings for cases that were impacted by these changes were first meetings set February 18, 2025 (Cruseturner) and February 20, 2025 (Brown).

#### Discontinuation of Chapter 13 Trustee events servicing

Effective March 18, 2025, the Clerk's Office will no longer send notices for all Chapter 13 Trustee events through the Bankruptcy Noticing Center (BNC). A list of events the BNC will no longer send notices for is below.

#### Judge's Hearings - Procedures and Preferences

<u>Judge Latta</u> - All court hearings conducted in Judge Latta's courtroom can be accessed for virtual appearance from the recurring Microsoft Teams link posted in the *Court Calendars and Appearances* tab on Judge Latta's webpages on the court's website, <u>www.tnwb.uscourts.gov</u>.

If your remote appearance will be **telephonic**, you must notify Courtroom Deputy Debra Hayes no later than 3:30 pm the day before your scheduled hearing and provide the telephone number from which you will be calling for identification purposes. You may be denied telephonic access to the hearing if you fail to provide this number. Please comply with the guidelines and instructions provided in the *Courtroom Appearances-Attorneys* section for appearing remotely. If you have any questions, please contact Courtroom Deputy Debra Hayes at 901–328–3570.

<u>Judge Croom</u> - Judge Croom's hearings are conducted in-person for all calendar matters. However, Judge Croom allows attorneys and parties to appear telephonically in certain situations. Telephonic appearances are NOT allowed if the matter requires a trial, evidentiary hearing, or witness examination. If you would like to appear telephonically, please contact Courtroom Deputy Deborah Pulse at 731-421-9314 NO LATER THAN noon the day prior to your hearing.

<u>Judge Hagan</u> - Effective January 6, 2025, for matters pending before Judge Hagan, out of town attorneys may only appear telephonically or by video conference in limited circumstances which includes Chapter 11 status conferences/announcements (when traveling to the jurisdiction is an economic burden to the estate) and scheduling conferences in Adversary Proceedings (when traveling to the jurisdiction is an economic burden to the estate) if you file a motion to appear telephonically or by video conference by **NOON** the day before the hearing and the Court approves your motion prior to the hearing.

You will no longer receive an email invitation for any matter in which Judge Hagan has <u>granted</u> a timely filed motion to appear telephonically or by video conference. See Judge Hagan's announcement regarding telephonic and video conferences. <u>This Microsoft Teams link</u> for any such motion that is timely filed and granted will be a recurring link that can be used to access the hearing. Access to the courtroom proceeding will be limited to movants associated with a granted motion to appear telephonically or by video conference.

<u>Judge Barnett</u> - Effective Tuesday, March 4, 2025, all court hearings conducted in Judge Barnett's courtroom can be accessed for virtual appearance from the recurring Microsoft Teams link. On Judge Barnett's <u>webpage</u>, the recurring link will be listed under the "Court Calendars and Appearances" tab. Please continue to follow the instructions for appearing remotely. The Court Call List will be provided on Judge Barnett's webpage.
