Motion to Sell Property and Motion to Sell Property Free and Clear of Liens Under Section 363(f)

Effective immediately, when a Motion to Sell Property or a Motion to Sell Property Free and Clear of Liens is filed, it must cite the Bankruptcy Code section or rule applicable to the request for relief (for example Section 363 (b), Section 363(c), Section 363(f), Rule 1303).

If Motion to Sell Property Free and Clear of Liens Under Section 363(f) is filed, a filing fee of \$199.00 is required.

Corrective entries will be applied if the motion asks to sell property free and clear of liens but does not cite the specific code or rule. Corrective Entries will also be applied if a fee is required and not paid.

Debtor's Certification Regarding Domestic Support Obligation and Debtor's Certificate of Plan Completion in the Eastern Division

Effective June 3, 2024, Chapter 13 Trustee Tim Iuy's office started accepting Official Form 2830, "Chapter 13 Debtor's Certifications Regarding Domestic Support Obligations and Section 522(q)." This form replaces Form MISC054, "Debtor's Certification of Plan Completion and Request for Discharge."

Form MISC054 has been removed from the court's website. The trustee is allowing filers until August 3, 2024, to use Form MISC054. After that date, the new form, Form 2830, must be used.

Beginning August 4, 2024, corrective entries will be applied when the old form, Form MISC054, is filed.
