**UNITED STATES TRUSTEE'S NOTICE OF APPOINTMENT OF  
SUCCESSOR CHAPTER 13 STANDING TRUSTEE**

PLEASE TAKE NOTICE THAT:

1. George W. Stevenson, a Chapter 13 Standing Trustee for the Western District of Tennessee, Western Division ("Trustee Stevenson"), has resigned from all his cases effective as of 11:59 p.m. on April 30, 2023. All of Trustee Stevenson's open Chapter 13 cases as of 11:59 p.m. on April 30, 2023, shall be referred to as "the Stevenson Cases."

2. Acting United States Trustee Paul A. Randolph, pursuant to 28 U.S.C. § 586(b) and 11 U.S.C. §§ 325 and 1302, has appointed Jennifer Kemp Cruseturner as a Chapter 13 Standing Trustee ("Trustee Cruseturner") for the Western District of Tennessee, Western Division effective 12:01 a.m. May 1, 2023; and has designated her as Successor Trustee in all the Stevenson Cases.

3. Effective May 1, 2023, the Acting United States Trustee, pursuant to 28 U.S.C. § 586(b) and 11 U.S.C. §§ 325 and 1302, thus transfers and assigns all the Stevenson Cases to Trustee Cruseturner.

4. Trustee Cruseturner's bond is fixed under the general blanket bond

authorized by the Acting United States Trustee pursuant to 11 U.S.C. §322 and Federal Rules of Bankruptcy Procedure ("FRBP") Rule 2010(a).

5. Pursuant to FRBP Rule 2012(b), Trustee Cruseturner, as the successor Chapter 13 Standing Trustee in the Stevenson Cases, shall prepare, file, and transmit to the Bankruptcy Court and the Acting United States Trustee, a separate accounting of the prior administration of each of the Stevenson Cases by May 31, 2023. Each accounting shall be served upon the case's debtor(s) and their current bankruptcy attorney of record.
