In CM/ECF Release 5.0, a new "Withdraw as Attorney" event may be available in your court's events list that allows attorneys to terminate themselves when their involvement in the case ends.

Slide 4 - Withdrawal as Attorney Overview

Withdrawing as Attorney



- Your court *may* allow attorneys to terminate themselves.
- If there is no controversy before the court and your client consents to your withdrawal, you can terminate yourself from a case.
- **Advantage:** You stop receiving notices on cases where you're no longer involved.

Slide notes

Your court may allow attorneys to terminate themselves in limited circumstances. If, as an attorney, you can certify that you have no controversy before the court and your client consents to withdrawal from the case,

...you can docket a new event that allows you to terminate yourself from a case.

The advantage to this is that you will stop receiving notices of electronic filings or other notices on a case where you are no longer involved.

Slide 5 - Slide 5

Withdrawing as Attorney Constraints

- Attorneys for debtor or joint debtor in a bankruptcy case will NOT be able to terminate themselves.
- Attorneys for a plaintiff or defendant who is also a debtor in lead bankruptcy case will NOT be able to terminate themselves.
- Attorneys can only terminate themselves and not the parties they represent. Parties will remain active and become pro se.
- Attorneys will NOT be able to terminate other attorneys on a case.

Slide notes

Features and limitations of terminating yourself from a case include the following: Attorneys for the debtor or joint debtor in a bankruptcy case will not be able to terminate themselves.

Attorneys for the plaintiff or defendant in an adversary proceeding who is also a debtor in a lead bankruptcy case will not be able to terminate themselves.

Attorneys may not terminate the parties they represent when they terminate themselves. The parties they represent will remain active and their representation status will become pro se.

Finally, attorneys will not be able to terminate other attorneys on a case.

Slide 6 - Filing Agents

Filing Agents



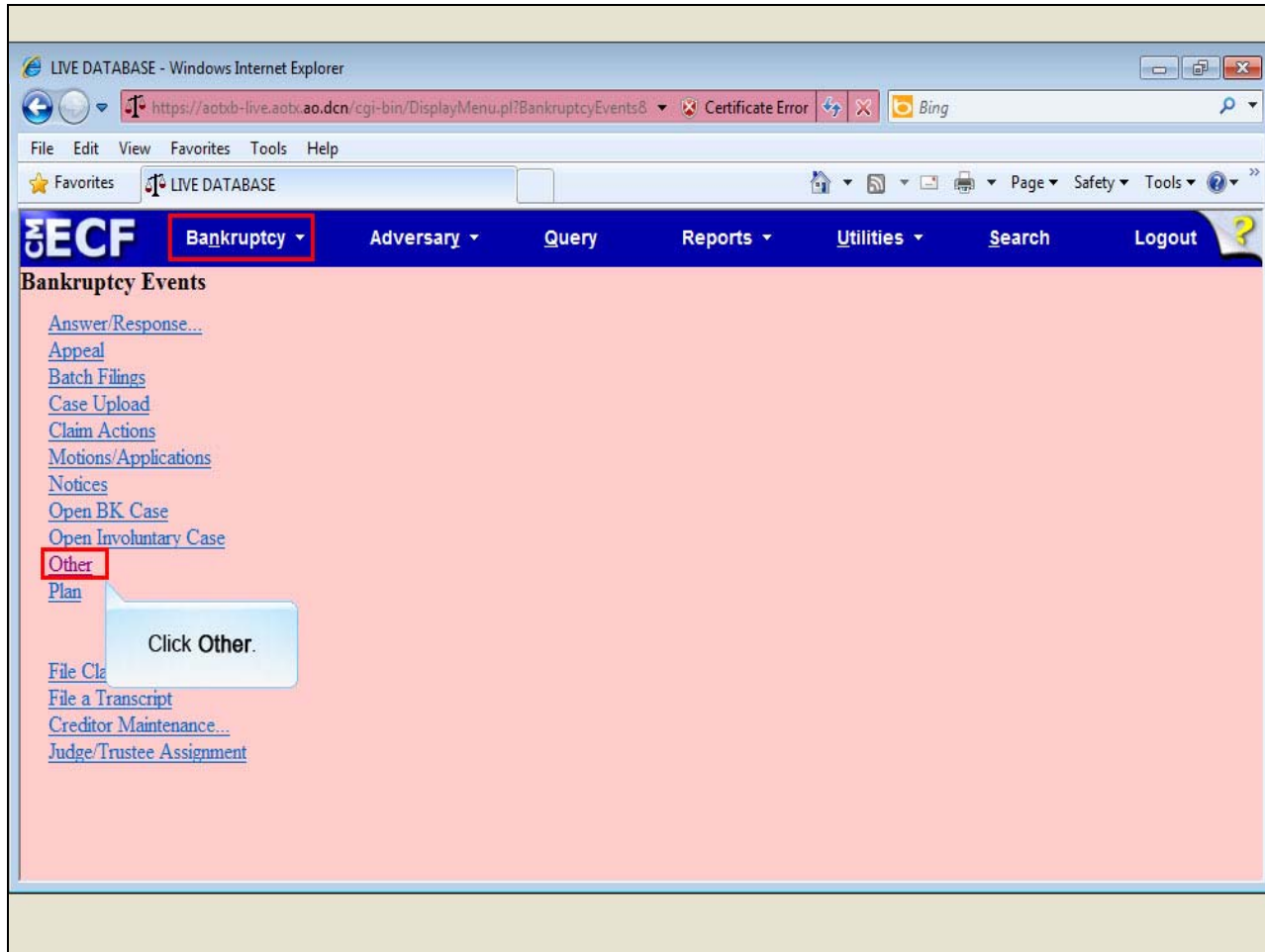
- Some attorneys use filing agents to docket pleadings.
- Filing agents docket events as if they are the attorney.
- Docket text reflects attorney, not filing agent, as the filer.
- Filing agents can terminate the attorneys they represent, just as if they were the attorney.

Slide notes

Some attorneys employ filing agents, such as paralegals or secretaries, to docket events for them. Filing agents log in as themselves, but file docket events as if they are the attorney.

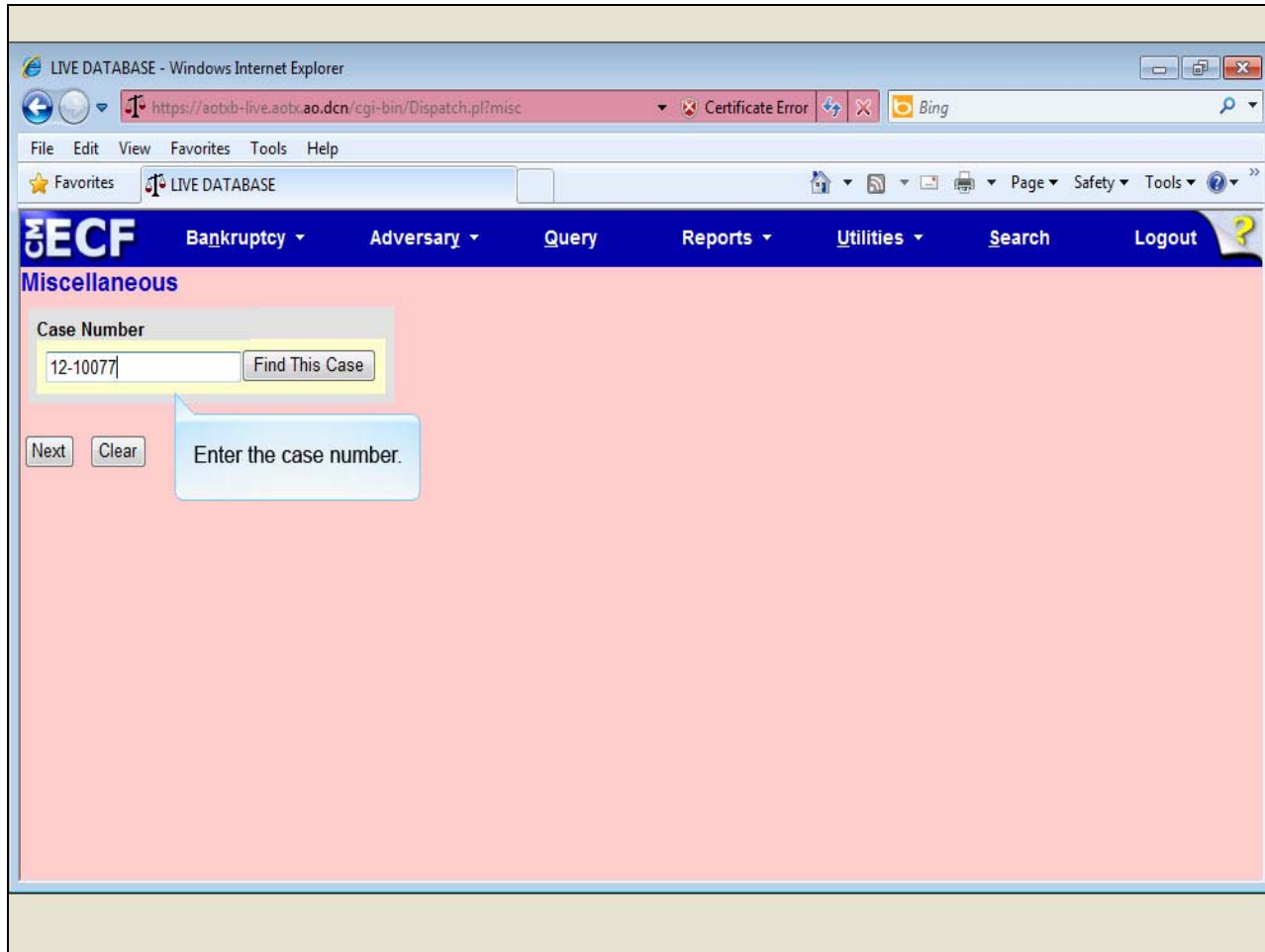
The docket text indicates that the attorney, not the filing agent, filed the event. Filing agents can withdraw the attorney with this new event as if they were the attorney.

Now, I'll log into CM/ECF as an attorney and demonstrate how to docket a Withdraw as Attorney event.

Slide 7 - Docketing Withdrawal as Attorney**Slide notes**

We begin at the CM/ECF Bankruptcy menu. I'm currently logged in as the attorney, Charlotte Baker, who represents the creditor, First Nationwide Mortgage. I'll start by clicking Other.

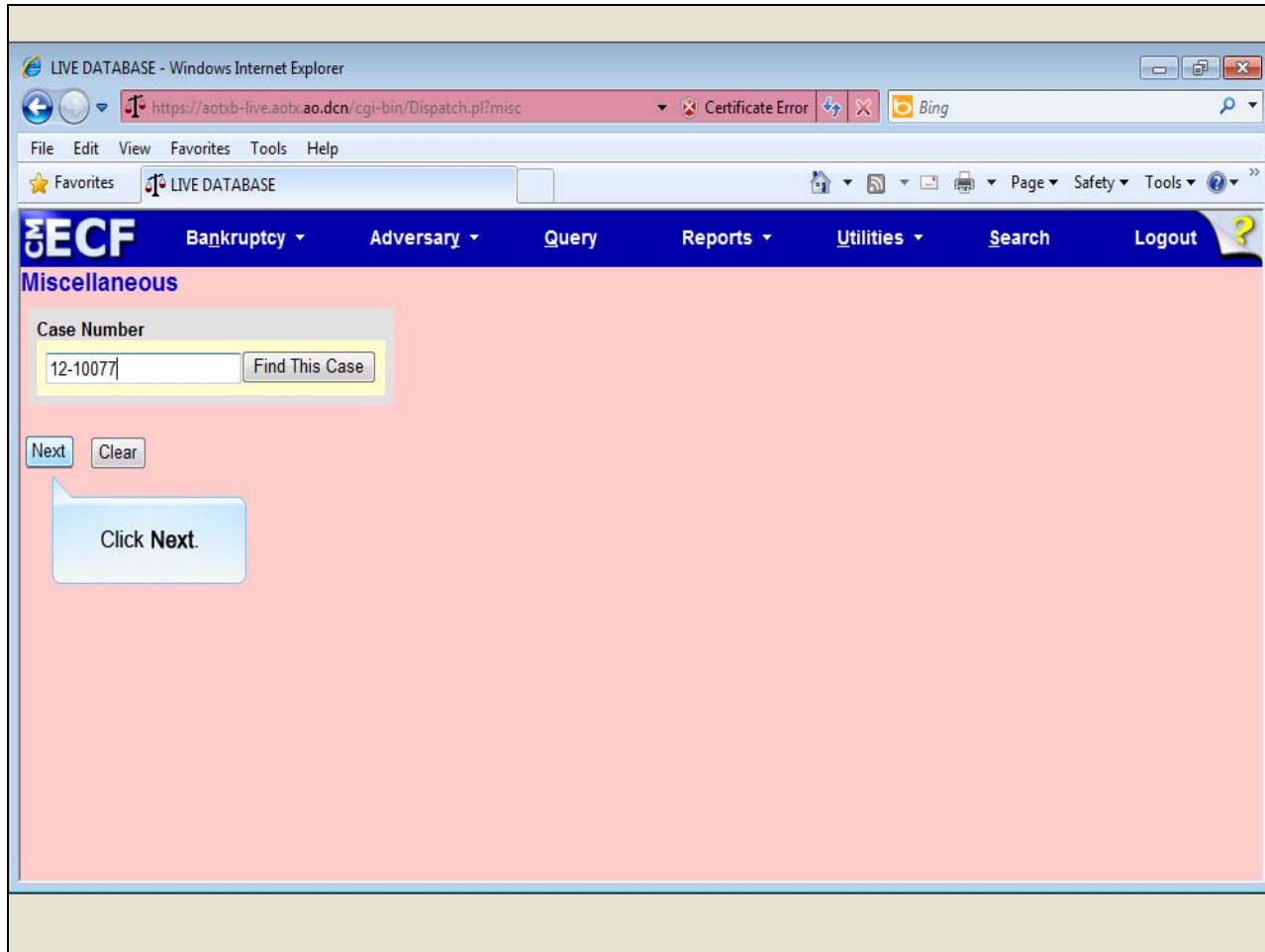

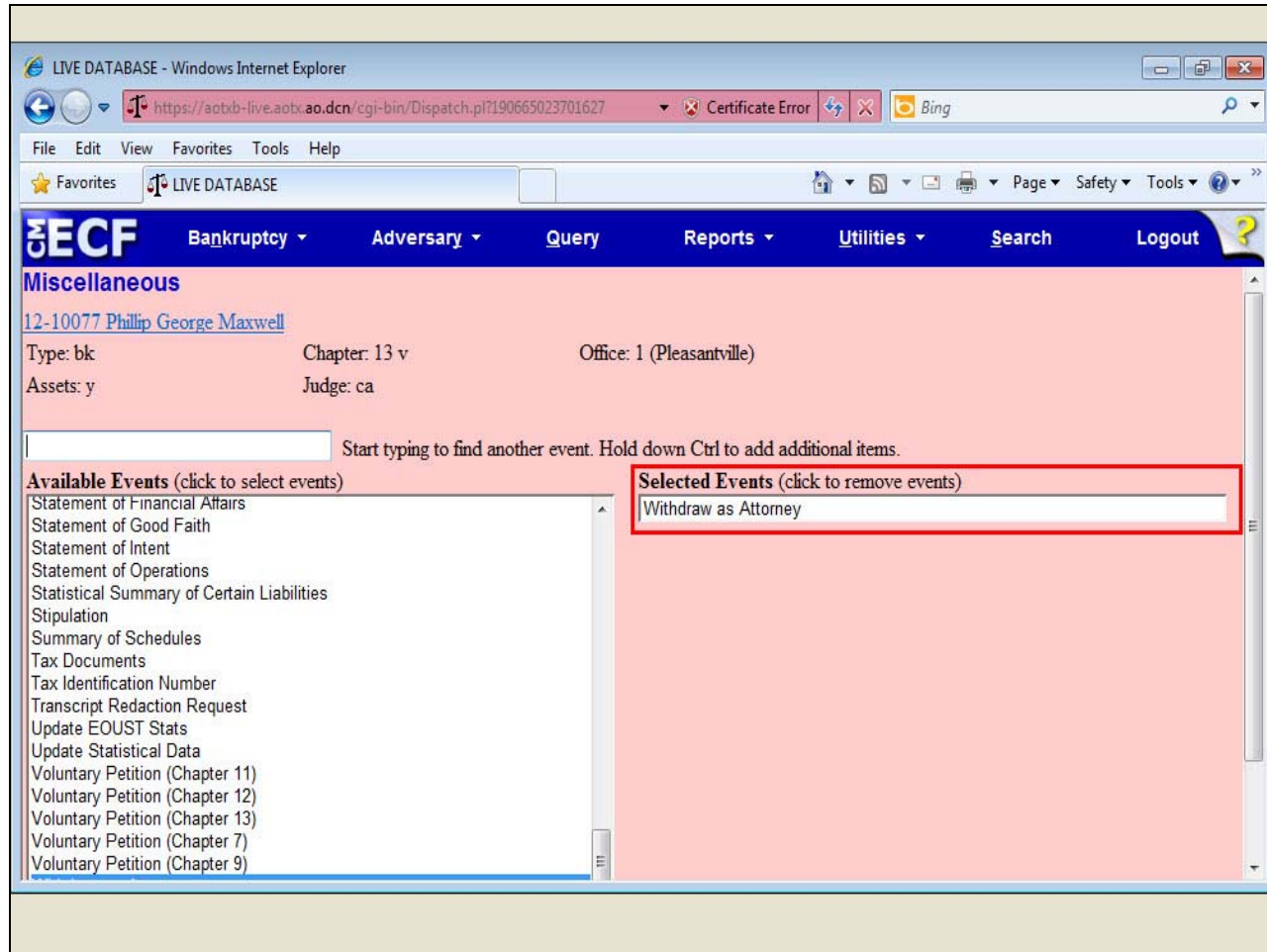

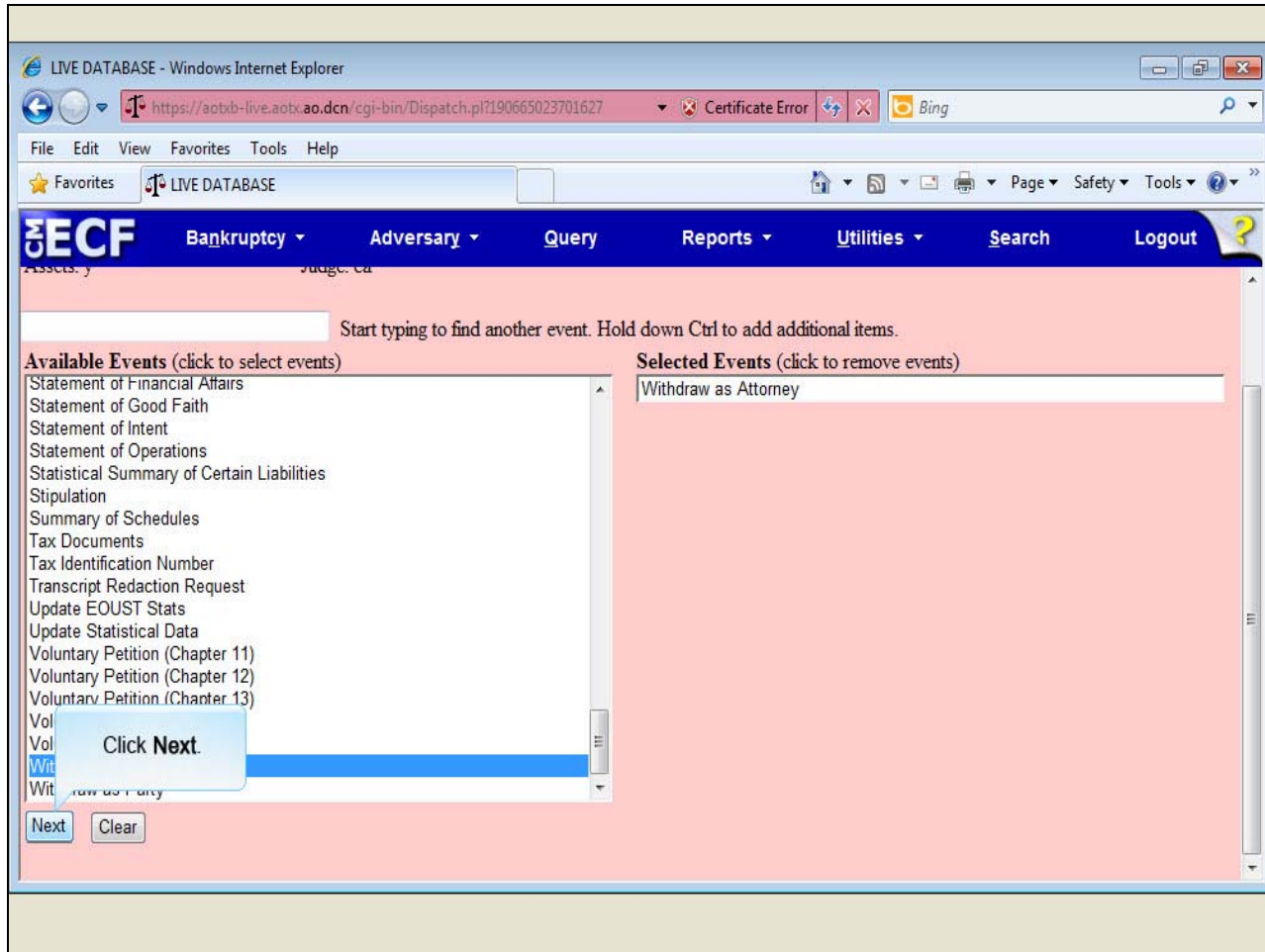
