



and Prior 12 Month Intervals**







Apr 01, 2017 thru Mar 31, 2018**










and Prior 12 Month Intervals**





Apr 01, 2018 thru Mar 31, 2019**




**Bankruptcy Case Closings
Apr 01, 2017 thru Mar 31, 2018**







