



and Prior 12 Month Intervals**







Jul 01, 2017 thru Jun 30, 2018**










and Prior 12 Month Intervals**





Jul 01, 2018 thru Jun 30, 2019**




**Bankruptcy Case Closings
Jul 01, 2017 thru Jun 30, 2018**







